REQUIREMENTS:

ELIGIBILITY:

- The applicant must be a non-EU/EEA/Swiss citizen.
- It is important to have a business idea that has the potential for growth that is innovative and scalable.
- An outline of the business idea, a market analysis, financial projections, and the impact that the business idea could have on the Dutch economy should be included in a comprehensive business plan.
- The best way to support the startup is to work with a recognized facilitator. There are a number of options that can be considered here, such as a business mentor, an incubator, or another company approved by the Dutch government.
- You should be able to demonstrate that you have the financial resources to support yourself and your business. A minimum of €1,000 per month is required by the applicant in order to qualify for the program.

○ Visa-Free Travel:

With visa-free travel within the Schengen Area, you'll be able to explore and expand your business across Europe with no restrictions whatsoever.

○ Pathway to Residency and Citizenship:

Upon completing five years of legal residency, you are eligible to apply for permanent residency or Dutch citizenship.

○ Family Reunification:

You can bring your family members to the Netherlands and they will have the same rights as you when it comes to residency.

○ Supportive Business Environment:

Take advantage of the Netherlands' supportive business ecosystem, including government incentives, tax reductions, and access to funding opportunities in order to grow your business.
