## PORTUGAL D2 STARTUP VISA

This is a unique opportunity for non-EU entrepreneurs, freelancers, and independent service providers who wish to establish their businesses in Portugal to do so with the Portugal D2 Startup Visa. As a result of the granting of this visa, the Portuguese economy will be able to attract foreign resources and investment, contributing to its growth.

### REQUIREMENTS:

#### ELIGIBILITY:

- Non-EU, non-EEA, non-Swiss citizens are eligible to apply.
- In order to succeed in Portugal, you must have a solid business plan that shows the potential for economic growth as well as the creation of jobs.
- The business should be able to demonstrate that it has the financial resources to support the business. A Portuguese bank can offer a loan in the form of a personal loan or a loan from personal savings.
- The applicant must provide evidence that he or she has sufficient funds to support themselves as well as any members of their family. In general, the amount recommended is at least €5,000 for the business, plus €9,870 per year for the main applicant, €4,935 for a spouse, and €2,962 for each dependent child under the age of 18 years old.

With visa-free travel within the Schengen Area, you'll be able to explore and expand your business across Europe with no restrictions whatsoever.
- **Pathway to Residency and Citizenship:**  
After five years of legal residency in Portugal, you will be able to apply for permanent residency or citizenship in Portugal.
- **Family Reunification:**  
It is possible for your family members to join you in Portugal and they will be granted the same residency rights as you.
- **Tax Advantages:**  
You can take advantage of the NHR tax regime, which offers tax exemptions and reduced rates on certain incomes to Non-Habitual Resident (NHR) individuals.
